## CHANGES AND REPAIRS TO THE EXTERIOR OF YOUR PROPERTY

Pursuant to the Declaration of Deed Restrictions and Covenants for each section in Newport, "no construction or erection of improvements upon any lot, tract or parcel contained in Newport, however classified, shall ever be commenced until the written approval of the Architectural Committee shall have been received."

Listed below are items that require ACC approval. This list is not all-inclusive:

- Construction or installation of any building, including sheds.
- Any addition to an existing building.
- Construction, installation or repair to any fence.
- Replacement of windows, gutters, wood, and siding.
- Exterior paint of any building located on your property.
- Removal of trees (except dead trees).
- Installation or replacement of walkways, driveways and/or extensions.
- Construction of any patio or addition to an existing patio.
- Replacement of roof (prior approval not required in event of an emergency, but home improvement request required with type of roofing material, etc:.
- Flag poles.

Home Improvement Requests ("HIR") are available on our website under resident documents. A completed HIR along with a copy of your plot plan showing the location of your improvement is required. The ACC committee meets the first and third Friday of the month (exception - month with five Fridays or Holidays). HIR must be received the Wednesday before the meeting.

Paint chips are required for all painting (even if it is the same color of existing improvement).

Permits & renewals are available in the management office. The cost per permit (renewal or new issue) is:

Lake & River Permit—\$10 each (separate permit required for each person over 16 yrs of age) Boat Launch—\$50

> Cost to have key issued is \$30 (this is a one-time fee) Lost key replacement \$100

#### **CRIME DETERRENT TIPS**

- 1. Alarm system.
- 2. Surveillance cameras.
- 3. Dog barking.
- 4. Leave car in driveway during day.
- 5. Keep garage door closed.
- 6. Leave TV or radio on during day.
- 7. Leave light on during day.
- 8. If you do not have viewer in door, install one.
- 9. Be sure outside lights are off during day.
- 10. If gone for extended period of time get neighbors to pick up newspaper from yard; take in your mail or make arrangements for post office to hold; set lights on timers; and notify sheriff's office for vacation watch.
- 11. Unattended trash cans (upside down) are an indicator that no one is home. Suggestion: If the trash is not picked up before you leave for work, you might consider putting your trash out in bags before you leave.
- 12. Keep vehicles locked while in driveway.
- 13. Remove all valuables from your vehicles.

#### **CRIME STATS**

December and January crime stats remain low. There were no residential burglaries; eight motor vehicle burglaries reported, four of which were in a 3 day period. Criminal mischief, however increased to thirty reported incidents. We increased patrol in the areas where incidents were reported and are pleased that only one incident has been reported as of February 17, 2015. ASSESSMENTS ARE DUE ON THE FIRST OF EVERY MONTH

Assessments received after the last day of the month in which they are due are subject to a monthly late fee of \$5.00 plus interest at the rate of 6% per annum. Payments more than four months late are subject to an additional collection fee of \$15.00 per month.

#### PROPERTY TAXES HOMESTEAD YOUR PROPERTY AND SAVE

If you owned your property on or before January 1, 2015 and you occupy your property, you are eligible to file for a homestead exemption. A homestead exemption provides an average savings of \$300 on your property taxes. Homestead exemptions must be filed no later than April 30, 2015.

If you or your spouse will turn sixty-five (65) years of age any time this year you can file for an over-65 exemption. This exemption will freeze your school taxes from this year forward and give you a large savings on your county tax. Over 65 exemptions may be filed any time during the year, however it is better to file them as early as possible.

Veterans and other persons on disability may also qualify for exemptions.

Form 11.13 is available on line at head.org and we also have them available in the management office. If you have questions about the form or need assistance in completing the form, please stop by the management office and our manager will assist you.

#### PROTESTING YOUR PROPERTY VALUE

In the next couple of months you will receive a notice from Harris County Appraisal District setting forth the 2015 value of your property. If you feel the value is too high, you have the right to protest the value. This can be done by completing the form you receive in the mail and sending it to HCAD or following the instructions for filing a protest online.

Again, you have to own your home on January 1 of the tax year. If you purchased your home in 2014 in an arms length transaction and the appraised value is higher than the purchase price, you should be able to have the sora slanied value reduced to the purchase price. You will need, however, to file the protest.

### **HISTORY TIDBITS**

#### March 2 - Texas Independence Day

*Texas Independence Day* commemorates the adoption of the Texas Declaration of Independence on March 2, 1836. This event marked Texas' independence from Mexico. Sixty delegates from all over Texas signed the declaration. Its language in many ways parallels the 1776 Declaration of Independence of the United States, which is observed on <u>Independence Day</u>, also known as "the fourth of July".

The Republic of Texas was annexed to the US by joint resolution of the US Congress nine years after the Texas Declaration of Independence was signed. The US Congress then admitted Texas as a constituent state of the Union on December 29, 1845. Texas Independence Day is an official holiday in Texas. Sam Houston Day is also observed on March 2, marking the birthday of the man who led the Texans to victory over Mexican troops at <u>the battle of San Jacinto</u>.

#### April 15 - Tax Day

*Tax Day* - Income tax was first introduced in the United States of America in 1861. A rate of three percent was levied on incomes above \$800 per year and the resulting revenue was used to help fund the American Civil War effort. However, income tax was seen as unconstitutional and the law was repealed in 1872. The idea of a tax on personal income, at a rate of two percent, was reintroduced in the Revenue Act of 1894, but the legal status of this kind of tax was still unclear. In 1913, the "Sixteenth Amendment" to the Constitution of the United States was ratified. This cleared the way for the modern income tax system in the USA.

The details of the income tax system have changed greatly since 1913. The top rates of tax have varied enormously and were particularly high during the First and Second World Wars and the Great Depression. Individuals and families with very low levels of income do not have to pay income tax and may receive some subsidy via the tax system.

In 1913 Tax Day, or the filing deadline, was fixed on March 1. However, it was moved to March 15 in 1918 and April 15 in 1955, where it has remained since then.

#### April 21 - San Jacinto Day

San Jaciinto Day - Around 1820, the area that is now Texas was part of the newly independent country of Mexico. However, there was a strong push for an independent Republic of Texas so, in 1835, the Texas Declaration of Independence was drafted and a provisional government was formed. This movement was supported by a wave of volunteers from the United States. In 1836, Mexican president Santa Anna travelled to Texas to bring down this uprising. His campaign started successfully and the Mexican forces regained control of a number of areas.

Texan forces fought and won the Battle of San Jacinto on April 21, 1836, and captured General Santa Anna afterwards. This event led to negotiations for Texas to become fully independent from Mexico. The site of the battle is now known as the San Jacinto Battleground State Historic Site, which is close to the Houston Ship Channel and the cities of La Porte and Baytown. The site features the San Jacinto Monument, which is 570 feet (or about 174 meters) high and the world's tallest masonry tower.

# DEPUTIES TAKE NO NONSENSE APPROACH TO TRAFFIC VIOLATIONS AND LOOSE DOGS

The precinct deputies as well as our contract deputies are taking a no nonsense approach to traffic violations which include speeding, failing to stop at stop signs, and no seat belts. Citations are also being issued for residents who fail to keep their dogs on a leash or in an enclosed area. Listed below are the *average* fines for these citations:



Speeding - \$165 - \$185 School Zone - \$185 - \$225 Failure to stop at stop sign - \$165 No seatbelt - \$130 Loose dog - \$125



#### ATVS PROHIBITED ON PUBLIC ROADWAYS AND COMMON AREAS IN NEWPORT

Newport MUD does not permit ATVs on the hike and bike trails or along Gum Gulley.

San Jacinto River Authority does not permit ATVs along the canal.

Centerpoint does not permit ATVs and other vehicles on the Highline right of way.

Deputies have been hired by the various entities to stop the ATV traffic.

You could be fined and your vehicle towed for trespassing on these various properties.

## **DANGEROUS DOGS**

# Dogs that meet the following criteria <u>may</u> be declared dangerous:

A dog that makes an unprovoked attack on a person that occurred in a place other than an enclosure in which the dog was being kept; or

A dog that commits an unprovoked act in a place other than an enclosure in which the dog was being kept and that act would cause a person to reasonably believe that the dog will attack and cause bodily injury.

All dogs and cats, whether considered dangerous or not are prohibited from running loose in Harris County. Owners of loose dogs and cats may be cited by Harris County Sheriff's Deputies or Animal Control for failure to restrain your pet(s) at all times. Fines could run as high as \$500 for this offense.

#### HOW TO RESTRAIN YOUR PET

- 1. Keep your pet in your house.
- 2. Keep your pet in your fenced in yard.
- 3. Keep your pet on a leash led by a person capable of controlling your pet.
- 4. Keep your pet attached to a line not longer than 6 feet that will keep your pet from entering a public walkway or street. You know your pet isn't dangerous but the person walking past your house doesn't know that.

PLEASE OBEY THE LEASH LAW AND KEEP YOUR PET(S) RESTRAINED AT ALL TIMES TO AVOID THE POSSIBILITY OF A TICKET RESULTING IN A FINE.
