The manager reported:

ACC

Director Gaudet reported that a variance over rear set back had been granted to LGI for 11 lots along South Diamondhead due to a surveyor error. A replat is in process and when recorded will negate the variance.

Deed Restriction

Director Bailey reported that there were 457 new violations in June and 660 in July and that 335 of those were closed. He reported that there are 16 pending petitions. He summarized that 35% of the violations are landscape; 17% trash cans in public view; 9% miscellaneous items in view; 8% RV's, Boats and/or trailers in view; 10% mold; 4% fence repair and 5% inoperable vehicles.
