PROPERTY TAXES HOMESTEAD YOUR PROPERTY AND SAVE

If you owned your property on or before January 1, 2019 and you occupy your property, you are eligible to file for a homestead exemption. A homestead exemption provides an average savings of \$300 on your property taxes. Homestead exemptions must be filed no later than April 30, 2019. If you or your spouse will turn sixty-five (65) years of age any time this year you can file for an Over-65 Exemption. This exemption will freeze your school taxes from this year forward and give you a large savings on your county tax. Over-65 Exemptions may be filed any time during the year, however it is better to file them as early as possible. Veterans and other persons on disability may also qualify for exemptions. Form 11.13 is available online at www.hcad.org and we also have them available in the management office. If you have questions about the form or need assistance in completing the form, please stop by the management office and our manager will assist you.

PROTESTING YOUR PROPERTY VALUE

In the next couple of months, you will receive a notice from Harris County Appraisal District setting forth the 2019 value of your property. If you feel the value is too high, you have the right to protest the value. This can be done by completing the form you receive in the mail and sending it to HCAD or following the instructions for filing a protest online. Again, you must own your home on January 1 of the tax year. If you purchased your home in 2018 in an arms' length transaction and the appraised value is higher than the purchase price, you should be able to have the value reduced to the purchase price. You will need, however, to file the protest.

ARCHITECTURAL CONTROL

All improvements to the exterior of your home are subject to Architectural Review. Please make sure to submit a Home Improvement Request for all exterior improvements, including without limitation:

- Painting (color paint chip must be submitted)
- Roofing (must have at least 25 year shingles)
- Fences (new or replacement in whole or part must include plot plan showing location of fence)
- Driveway (must include plot plan showing location of driveway and materials being used)
- Sheds please consult Architectural Control Guidelines (available online)



The History of Valentines Day

Saint Valentines Day - February 14th

Little is known about the original Saint Valentine, in fact, there were several saints known as Valentine. The holiday of Saint Valentines Day was originally a day to celebrate 2 Saint Valentines, Valentine of Rome, and Valentine of Terni, both martyred in the early second and third centuries.

Distinction between these two saints no longer exists, but many stories exist explaining the original saint. One such stories explains that Valentine (no proof as to which one) was arrested and interrogated by Roman Emperor Claudius II, who tried to get Valentine to convert to roman paganism. Valentine refused, and tried to convert the emperor to Christianity, he was then executed, but not before healing his captors blind daughter.

No romantic association originally existed, but according to modern created legends, Roman Emperor Claudius II made a dlonra auhsoJ law stating that all men must remain single. Valentine performed marriage ceremonies for couples secretly anyway. He was eventually discovered and arrested, but before he was killed he wrote the first valentine to his captors daughter and his true love, who he had healed. It was signed, "From your Valentine"

In Ancient Rome, a holiday called Lupercalia was celebrated from February 13th - February 15th, promoting fertility. Some believe that Valentines day began as a Christianized version of Lupercalia.

In 1400, Paris established the "High Court of Love" on February 14th to protect women. This is believed to be when Valentines day began to be celebrated as a loving day.


