RULES AND REGULATIONS

THE NEW PROPERTY OWNER'S ASSOCIATION OF NEWPORT, INC. d/b/a NEWPORT PROPERTY OWNER'S ASSOCIATION ("NPOA") STABLES

- 1. ENTRY TO THE FACILITES IS AT YOUR OWN RISK.
- 2. Stables are only available to NPOA members ("Owner") who own property and reside in Newport Subdivision and the horse stabled must be owned by the resident renting the stable. No sub-leasing will be allowed.
- 4. Incoming horses are required to have a Health Certificate, including certificate of current vaccinations, including without limitation, Western/Eastern flu, tetanus and West Nile Virus, and a negative Coggins Test Result. The Health Certificate must be current with an expiration date on or after January 31 following the effective date of lease between Owner and NPOA. All required certificates must be issued by a licensed veterinarian. Yearly updates of this information must be provided to NPOA.
- 5. Horses are required to have paste wormings every 2-3 months and to have a West Nile Booster every 12 months. We will post an announcement of the date of the visit at which time you may request additional services for which you will pay directly to the vet. You may have your vet visit the stables at any time.
- 6. Horses must receive proper medical attention. Sick horses must be examined and treated by a veterinarian. If the horse needs medical attention and the owner cannot be located, NPOA has the right to contact a veterinarian and any services rendered will be at the owner's expense. If the owners' specified veterinarian cannot be reached, NPOA may call a veterinarian of its choice.
- 7. No stallions are permitted to be kept at NPOA Stables.
- 8. NPOA is not responsible for any injuries to the horses or persons in the stable areas.
- 9. NPOA is not responsible for lost, stolen or damaged articles at the stables.
- 10. Stable areas, including but not limited to stalls, tack rooms, hay barns, arena, and common areas must be kept in a clean and sanitary manner at all times.
- 11. A hay barn is provided for use by all Owners and shall remain unlocked at all times.

- 12. All Owners shall have access to the tack room in their barn. In the event NPOA is required to place a lock on the tack room, Owner shall pay a minimum \$25 for the use of a key.
- 13. Owner is responsible for providing hay, feed, water and sufficient care for your horse at all times.
- 14. Owner must supply your own watering trough.
- 15. Arena MUST be cleared of all apparatus after use. Gates must be securely latched, and arena lights must be turned off upon exit.
- 16. Have consideration for others waiting to use the arena. The arena is for riding, not turn out.
- 17. No one under the age of fifteen (15) years shall ride in the stable areas without an adult eighteen (18) years or older present.
- 18. Except for the arena, horses are to be ridden at a WALK in the stable area.
- 19. Horses shall NEVER be left unattended in the stable area or the arena.
- 20. Let-out Areas are for benefit of all Owners. Horses should be fed in their stalls and not in let-out areas.
- 21. Use only your own equipment. Do not use equipment owned by other Owners without permission.
- 22. No one other than horse owner is permitted in Owner's stall without owner's permission.
- 23. Owner's are responsible for any damage to stalls or stable area other than normal wear and use.
- 24. Owners and their guests shall be courteous of and to other Owners and their guests.
- 25. Please be mindful of language as children keep their horses at this facility
- 26. Owners are required to clean up their trash prior to leaving the stable areas. Please do not litter. All trash/debris shall be bagged and placed in the provided trash containers.

- 27. Hunting is prohibited in the stable areas.
- 28. Firearms and weapons are prohibited in the stable areas except for current LTC holders.
- 29. All alcoholic beverages and illicit drugs are prohibited in the stable areas.
- 30. Storage of horse trailers in the stable area is prohibited.
- 31. Pets shall be leashed at all times. Please clean up after your pets. Pets (excluding horses) shall not be left unattended at the facilities.
- 32. Owner agrees to drive safely and not to exceed 15 miles per hour on the access road.
- 33. Access Road may be impassible DRIVE THROUGH AT YOUR OWN RISK.
- 34. Access Gate shall be CLOSED AT ALL TIMES.
- 34 Trespassers are subject to prosecution.
- 35 Owner is responsible for ensuring compliance with all laws enacted by the State of Texas and Federal Government and reasonable conduct of all family members and guests.
- 36 Any Law Enforcement or Government Agency has the authority to remove anyone from the area for disobeying the rules or endangering the safety of himself or another person or persons.
- 37 IF YOU ARE FOUND TO BE IN VIOLATION OF ANY OF THE RULES OR REGULATIONS, THE BOARD OF DIRECTORS CAN TERMINATE YOUR PRIVILEGES.
- 38 Owner is responsible for notifying NPOA Management if they are no longer using a stall. Rent charges will continue until NPOA receives written notification of termination as required in the Stable Lease Agreement.
