#### Call to Order

#### **Minutes**

#### **Discussion/Action Items**

The manager told the Board she had been contacted by a representative of the company that is planning to build a senior community in front of Newport on FM2100. Kings Port Street is shown by the County to continue to FM 2100 and currently dead-ends at the end of Newport. The owners plan to have the portion of the road outside Newport abandoned and wanted to know if the Association would object. The manager also told the Board she had discussed the possibility of permitting the residents of the senior project to access our lake and river facilities and possibility our storage facility. The Board agreed this could be a possibility with the Owner of the senior facility paying a monthly assessment of not less than \$1,000 per month. The manager was authorized to discuss this further with the owners of the project. The Board also had no objection to the road abandonment and directed the Manager to write a letter is required by the County.

A motion was made by Dan Kasprzak to update the signatures on the Association's checking account at Community Bank of Texas by removing **Name Removed** and adding **Name Removed** as a signatory. The motion was seconded by Earl Boykin. The motion passed unanimously.
