#### **GUEST SPEAKER**

Jeremy Phillips, Director of Road and Bridge Operations for Harris County, Pct. 2 spoke about current and future plans that would affect Newport. He reported:

- A new playground had been installed at Crosby Park and Sports Complex;
- Drainage was completed last year on Holstein Road;
- Widening of FM2100 through Barrett Station should be completed by October 2016;
- Work is planned for the sections along Port O'Call (Sections 1,3,5 and 6) to address potholes, etc.
- Bond was passed last year for subdivision reconstruction. \$800,000 is slated for Newport. Pct. 2 will notify NPOA in advance before any repairs take place.
- There are no immediate plans to widen Golf Club Drive

Mr. Phillips answered questions from the residents including questions regarding placing a traffic light at FM1942 and Garth Road and the widening of FM 2100. Mr. Phillips explained that both of these issues fall under Tx Dot and not Harris County.
